Mixed Marriage Dispensations

- Preparation of the non-Catholic party:** The non-Catholic party has been instructed on the doctrine of the Catholic Church with regard to Christian marriage and recognizes that the marriage he/she wishes to contract is to be one and indissoluble. The non-Catholic party is aware of the responsibilities of the Catholic party with regard to religious practice and to the Catholic baptism and education of children.
